**GPS:** Intersection of U.S. Route 1 and Wynwood Drive, Monmouth Junction, NJ

Office is located in the yellow with white porches office condominium building located at 4105 Route One, Suite 9.

**DIRECTIONS FROM WEST WINDSOR**

Rte. 571/Prt.-Hightstown Rd, to Route 1 North to Wynwood Drive Exit in the town of Monmouth Junction, South Brunswick. You will go past Scudders Mill Road, Princeton Forrestal Village and past Route 522 (also called Stouts Lane) to Wynwood Drive exit; take jug-handle and go across Route 1 and make your first left into a parking lot of the Office Condominiums. (Up ahead and to the right is Bandito's Mexican Restaurant, Home Depot Shopping Center). Proceed to the end of the parking lot and turn left. We are located in Suite 9.

**DIRECTIONS FROM EAST WINDSOR**

Rte. 130N, at intersection with traffic light and Constitution Bank (on right), make a left (west) onto Dey Rd., turn right on Scudders Mill (Queenship of Mary Church is on the corner) and take route one north exit. Take Route One North, you will go past Scudders Mill Road, Princeton Forrestal Village and past Route 522 to Wynwood Drive exit; take jug handle and go across route one and make your first left into a parking lot of the office condominiums. (Up ahead and to the right is Bandito's Mexican Restaurant, Home Depot Shopping Center). Proceed to the end of the parking lot and turn left. We are located in Suite 9.

**DIRECTIONS FROM N. BRUNSWICK**

Take US 1 south to Wynwood Drive exit, which is past Sand Hill Road and past New Road. Take Wynwood exit and go straight across Wynwood Drive into a parking lot of the yellow office condominiums. (To the right is Bandito's Mexican Restaurant, Home Depot Shopping Center). Proceed to the end of the parking lot and turn left. We are located in Suite #9 in the back of the Office Complex

**DIRECTIONS FROM MERCER COUNTY**

Take Route 1 North, past the Forrestal Village on your left, past Raymond Road (traffic light), past Route 522 (traffic light) and take the Wynwood Drive jug handle. Cross Route 1 and make the first possible left. The front of our building (yellow with white porches) faces Route 1 South, but the entrance is on Wynwood Drive, about 20 feet from Route 1 South.

**DIRECTIONS COMING FROM NORTH OF THE OFFICE**

The address is in Monmouth Junction, which is a town in SOUTH Brunswick. If you are going to do map quest or a navigation system, do the intersection of Wynwood Drive and US Rte. 1 South. At some point, you will be coming south on Route 1, go past the water tower on your left, Wendy's and Burger King (traffic light) on your left, McDonald's on your right (traffic light), the next traffic light is New Road. Go about 100 yards past a dumpy Mexican restaurant and then a strip mall with Stop & Shop and Home Depot. The end of the strip mall has a little road, Wynwood Drive, make a right on Wynwood Drive and cross over into our office condo complex; the entry is about 50 feet from Route 1 south. Do not go right or left onto Wynwood Drive, just cross it perpendicularly into our driveway. If you reach the alternative entry to the strip mall, you've gone too far. Once you are in the complex, you will see the typical office sign. Go straight to the back and make a left. We are Suite # 9.
